

The Falcon Chambers Arbitration Rules

Effect of these Rules

- 1 These Rules govern the appointment of a Falcon Chambers Arbitrator and the conduct of a Falcon Chambers Arbitration in accordance with a Falcon Chambers Arbitration Agreement.

Appointing a Falcon Chambers Arbitrator

- 2 Parties who have agreed to arbitrate an existing dispute may request the appointment of a Falcon Chambers Arbitrator under these Rules by filing with the Falcon Chambers Arbitration Clerk a copy of a written Arbitration Agreement in the form at:

- 3 signed by both parties.
- 4 The appointment will take effect once the Arbitrator has counter-signed the Arbitration Agreement and a copy has been emailed by the Falcon Chambers Arbitration Clerk to each Party (and, in the case of a Falcon Chambers Bespoke Arbitration, once the Arbitrator's Fee has been agreed with the Falcon Chambers Arbitration Clerk).

Conduct of the Arbitration

- 5 The Arbitration shall be conducted in accordance with the provisions of the Arbitration Act 1996 and the Falcon Chambers Arbitration Directions, with such modification of those Directions as the Parties may agree or the Arbitrator may think fit.
- 6 Subject to the agreement of the Parties, all documents and statements may be delivered by email to ArbitrationClerk@falcon-chambersarbitration.com

Arbitrator's Fees

- 7 The Arbitrator's fees will be agreed in advance with the Falcon Chambers Arbitration Clerk. If the Parties wish to adopt the accelerated procedure set out in one of the Schedules to the Falcon Chambers Arbitration Directions, fees will be charged in accordance with the following scales:
 - n 20 Day Arbitration: £3,000 for an Arbitrator other than a KC.
 - n 40 Day Arbitration: £6,000 for an Arbitrator other than a KC.
 - n 20 or 40 Day Arbitration with a KC Arbitrator: to be agreed in advance with the Falcon Chambers Arbitration Clerk

- 8 If the parties wish the Arbitrator to determine the question of costs under the accelerated procedure (including as appropriate the liability for payment of all or part of the arbitrator's fees), there will be a fee in addition to those fixed fees set out above, as follows:
 - n 20 Day Arbitration: £450.
 - n 40 Day Arbitration: £600.
 - n 20 or 40 day Arbitration with a KC Arbitrator, to be agreed in advance with the Falcon Chambers Arbitration Clerk

- 9 If the Arbitration settles before production of the Award:
 - (a) the Arbitrator's fee will be calculated according to time spent, by reference to his or her normal hourly rate, subject to the stated maximum;
 - (b) the terms of settlement shall be notified to the Arbitrator, who will, if the parties wish, upon payment of the fee, issue an Agreed Award incorporating the agreed terms of settlement.

- 10 The above fees are exclusive of any costs of hiring a venue or refreshments for any hearing which, if organised through FCA, will be agreed separately with the Falcon Chambers Arbitration Clerk.
